Thank you for the crucial role you have played in ensuring KPFA's independence from the stranglehold of corporate sponsorship. Below is a tax accounting that satisfies all IRS substantiation requirements for donations made the preceding year. Thanks to your generous financial support, KPFA is able to provide an outlet for voices and ideas that are silenced everywhere else.

Changes in Tax Law:

Enactment of the Omnibus Reconciliation Act of 1993 creates new record-keeping requirements for donors to tax-exempt organizations. Donors who receive a "premium" (e.g. DVDs, tickets, T-shirts, books. etc.) may deduct only the amount of the contribution *minus* the value of premium.
